

Celebrateally Privacy Policy

This Privacy Policy outlines how Celebrateally collects, uses, shares, and stores your personal information when you use our services or visit our website. It aims to help you understand your privacy rights and choices regarding the handling of your personal information.

1. Information Collection:

3. Information Sharing:

Your information may be shared in scenarios such as company sales or mergers. Additionally, we share information with third-party agents performing tasks on our behalf (e.g., email sending, billing, payment processing) under obligations to maintain confidentiality and security.

4. Interaction with Other Users of the services:

Certain service features may allow you to interact with us and others publicly. Information you choose to submit, such as your name, username, location, email address, profile information, and comments, may become publicly available. Celebrateally is not responsible for any information you decide to make public.

5. Data Retention:

We retain your information as long as necessary for the purposes outlined in this Privacy Policy, unless a longer retention period is mandated by law.

6. Data Security:

Celebrateally employs organizational and technical measures to protect your personal information. However, no internet transmission is entirely secure, and we cannot guarantee that unauthorized parties will not breach our security measures. Transmission of personal information to and from our services is at your own risk. We encourage secure access to our services.

7. Minor's Privacy:

We do not knowingly collect data from or engage in transactions with individuals under 18 years of age. By using our services, you represent that you are over 18. If we learn of any inadvertent data collection from minors, we will deactivate the account and remove the data from our records.

8. Your Privacy Rights:

You may review, change, or terminate your account at any time. Withdrawal of consent is possible, but it will not affect the lawfulness of processing based on consent before its withdrawal. You may opt-out of promotional communications by using the unsubscribe link.

9. Analytics:

We use Google Analytics with IP anonymization for business analysis. Google processes information on our behalf to evaluate service usage and compile reports. Users can prevent cookie use through browser settings.

10. SSL Encryption:

Our site uses SSL encryption to protect the transmission of confidential content.

11. Cookies:

We use session cookies, which are deleted after your visit, and persistent cookies, which remain on your device until deleted. These enable browser recognition on subsequent visits. Deleting cookies may limit site functionality.

12. California Residents:

In accordance with California's Shine The Light law, residents of California who use our site are entitled to request, once per year and without charge, details regarding the categories of personal information we have disclosed to third parties for direct marketing purposes, as well as the names and addresses of those third parties, for the previous calendar year. If you are a California resident and wish to make such a request, please reach out to us directly.

For minors residing in California, the law provides the right to request the removal of any personal information that you have publicly posted on our services. If you wish to have such information removed, please contact us using the email associated with your account, including a statement verifying that you are under 18 years of age and a California resident. We will make efforts to ensure that the data is not publicly displayed on our services. However, please be aware that we may not be able to completely or comprehensively remove all of your data from our systems.

13. Information Categories Collected:

We collect various categories of personal information, including identifiers, commercial information, internet activity, geolocation data, but not gender, biometric, professional, educational, or sensitive information. This information is used and retained to provide requested services as long as you have an account with us.

14. Data Deletion Request:

Upon request, we will delete your personal information, subject to legal exceptions. We do not discriminate against those exercising privacy rights.

15. Data Security:
